#### Online Learning – Safeguarding our Children

Now that our online learning is well underway, we want to remind you that it is vitally important for us all to work together to ensure that the children are as safe online as they possibly can be. We have therefore updated our **Google Meet Acceptable Use agreements** to include a **Parent section** (you will have already received the Child agreement). The updated document is attached and also available on the school website. Obviously, at the moment it is difficult for us to collect signed copies of this agreement, but please read it carefully as these are the behaviour expectations that need to be followed by all. Two key points to draw your attention to are:

- A parent/carer should always be within earshot of any Google Meet that their child attends
- Children should be dressed appropriately, ie not in their pyjamas!

## Children attending School – please read

While it is clear that the vast majority of our families are following National Lockdown Stay at Home Guidance (see <a href="here">here</a>), and for this we are grateful, it saddens me to say that there have been a few recent cases of children attending school talking freely to staff about mixing with other households. Not only does this compromise the safety of the whole community but it raises staff anxiety levels considerably. We will follow up on individual cases and further incidents will result in the child being asked to stay at home for 10 days and, potentially, losing their school place.
